



## TERMS AND CONDITIONS

### Coople's Winter Bonus

The organizer of this competition is Coople (Switzerland) Ltd. By participating in Coople's Winter Bonus you fully agree and accept the terms and conditions. **The competition will run between 01.11.2022 – 22.01.2023.** Winners will be selected at random. CHF 1'000 will be awarded to three Cooplors who each meet the entry criteria below. Participation is voluntary and free of charge.

#### Winner criteria:

- You are an employee registered with Coople.
- **You have filled in the entry form** to participate in the competition. All your shifts during the period of the competition count, even if you don't fill in the entry form until after your first shift.
- You have completed at least 5 shifts between 01.11.2022 – 22.01.2023.
- You do not have any strikes at the end of the competition at 22.01.2023. Strikes are applied when you cancel a shift with less than 24 hours' notice, or don't attend without letting us know (no show). If you have strikes, you are still eligible to win by removing all strikes before the competition ends on 22.01.2023 [Learn how to remove strikes.](#)
- You have zero record of lateness throughout the duration of the competition (unless you can provide reasonable justification).
- You have achieved an average star rating of at least 3 stars.
- You have an active profile as of 22.01.2023.

Registered participants who do not meet all of the above criteria are not eligible to win.

Entries should only be made by Cooplors who meet the above criteria - registrations through third parties, agencies or automated means (e.g. scripts and macros) will not be accepted and will prevent the entrant from participating in future contests. Entries that do not meet the conditions will be disqualified.

Cooplors may complete several work assignments (shifts) at different locations in one day. Each shift counts towards Coople's Winter Bonus. There is no minimum duration of assignments.

The maximum working hours permitted by labour law must not be exceeded and the legally prescribed breaks must be observed. Do not overwork yourself!

You must fill in the entry form in order for your shifts to count towards Coople's Winter Bonus. Any shifts completed before you filled in the entry form but during Coople's Winter Bonus period will be counted towards your Winter Bonus entries.

## How to remove strikes from your account:

- If you have strikes on your account, you'll need to remove them before the competition ends to be eligible to win Coople's Winter Bonus.
- To remove a strike, you'll need to work eight shifts in a row without receiving any further strikes. The eight shifts can be completed over any period; however, you must have zero strikes by the end of the competition at 23:59 on 22.01.2023.
- If you have strikes and they are removed before the end of the competition at 23:59 on 22.01.2023, all of your completed shifts (between the period 01.11.2022 – 22.01.2023) will count towards your competition entry total. You will not lose any entries if your strikes are removed.
